### **Letter from Mayor Chris Fiore**

Good morning all --

Nice treat to have a 50 degree weekend...but we are back to winter this week. Don't put your ice melt away!

Many of you have expressed concern about **cell service** in the Village. Dep.Mayor Claas Abraham and I, along with our Village Clerk, met with a representative of a company who is interested in our joining other local villages and Towns (we all have the same issue with poor cellular service) and I will ask the Trustees at our next meeting to approve the expense for engagement. The Towns of Southold and East Hampton, as well as the Village of Sag Harbor, are very keen on a 5 way commitment (the Town of Shelter Island is considering), and I believe we will all benefit from the knowledge this company can share with us. They will do a comprehensive review of service availability and give us recommendations on remedies. There are technologies other than towers; this firm will cover all options, and we are not under any obligation. We will keep you informed.

We are looking for bids to resurface the **tennis court** before the summer season. We are also considering building a second court that

would be dedicated to two pickleball courts. We currently house both sports on one court. **Pickleball** on residential properties is another matter, however. The Trustees and I will vote on a moratorium (6 mos) on residential pickleball construction.

We want to see results of a commissioned sound study that E Hampton Village is conducting, and study neighboring villages for their approaches to this topic. Pickleball is fun, no doubt. And it is the fastest growing sport in the US. But it creates a whole lot more noise than tennis -- and at a more piercing sound level. Let's take a breath and do our homework first.

The Park!! We are close to the winter removal of invasives from the area north of the pond, and will see the planting of native trees and shrubbery to replace the phragmites, multi flora rose (it's not a 'rose' -- its an invasive weed and will smother native plantings), and the ever popular mile-a-minute. Sam Panton's plan calls for hundreds of new, native trees and shrubbery which we hope will be planted this Spring. There are a couple of approvals still needed, but I am confident we will see a wonderful greenspace to be enjoyed by all this summer. Check out the site plan on our website.

**BIKES!** Let's try it again. The Riverhead Bike Coop, seriously touched by our Village's 300 donations last spring, would love us to organize another bike drive — this time I would like to invite Sag Harbor and Bay Point to participate. Look for news of this drive as we approach May.

Lots of talk and suggestions about **speed humps** -- not 'bumps' but rather the smoother humps as you might see on Glover Street in Sag Harbor. They are effective in slowing traffic and discouraging cut-thru trucks, Many communities are either considering or have installed these -- Sunset Beach Road has been a suggestion. What do you think?
