**A LOCAL LAW AMENDING CHAPTER 103– Section §103-1 – Deposit of wastes on
Public or Private ~~Village-owned~~ property **within the Village of North Haven** and
Section §103-2 Penalties for offenses**

Section 1. Legislative Intent

It is the intent to amend this code to include both private and public properties within the Village and to increase the associated fine.

Section 2. Amending the following sections of Taxation Chapter 103 - Littering

CHAPTER 103 - LITTERING

§ 103-1. Deposit of wastes on **public and private ~~Village-owned~~ property:-**

No person shall throw, place or in any manner deposit upon **public or private** property ~~of the Village of North Haven~~ any garbage, rubbish, papers, food containers, **construction materials packaging or debris** or any other litter whatsoever.

§ 103-2. Penalties for offenses. [Amended 8-4-1986 by L.L. No. 7-1986]

Any person committing an offense against any provision of this chapter shall, upon conviction thereof, be guilty of a violation pursuant to the Penal Law of the State of New York, punishable by a fine not exceeding ~~\$250~~ **\$500** or by imprisonment for a term not exceeding 15 days, or by both such fine and imprisonment. The continuation of an offense against the provisions of this chapter shall constitute, for each day the offense is continued, a separate and distinct offense hereunder.

Section 3. Severability.

If any sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance, shall be adjudicated by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 4. Effective Date.

This local law shall take effect immediately upon filing with the Secretary of State.

All persons in interest will be heard by the Board of Trustees at the public hearing to be held as aforesaid and may appear in person or by representative. The Village Hall is accessible to handicapped persons.
