#### **Letter from Mayor Chris Fiore**

Good day all--

Many thanks for all your emails in support of the newly announced speed limits on Ferry Road -- very much appreciate your thoughts. Here's the plan: DOT to replace the speed limit signs "soon". They will inform me of the dates for installation and we will alert you all. There will be digital (articulated) signs installed on a temporary basis (2-3 weeks), a "new" banner on the permanent signs, and radar speed signs (also temp) until drivers get familiar with the new limits. I asked for a "35 mph" painted message on the road itself, but DOT went for aesthetics over safety last time; I'll try again!

We will also request additional attention from our team of TOS police officers to monitor speeders in our Village.

All these things together should make travel -- vehicular, pedestrian, bicycle, etc., substantially safer on this main thoroughfare. Let's all do our part!

Good news about our park project -- Billy Hajek, our environmental consultant, and Scott Middleton, our village attorney, met last week with the 2 principals of the CPF (the Town agency that funded the Lovelady purchase). Happy to report the meeting was both positive and productive. Our village engineers and Sam Panton, our designer, will be providing additional information and the wheels will begin turning again

very soon. There will be updated information for you to read on the website by the end of this week.

There is a Board of Trustees meeting on Wednesday, October 18 at 5:00pm (also on Zoom) at Village Hall. We will also resume BOT work sessions Tuesday, October 24 at 10am, where we will consider Board projects for the upcoming months. All are welcome, but there is no public participation at a work session.

We are also busy interviewing candidates for the position of Village Clerk -- we are hopefully close to a solution.

#### **Community News**

- The gas-powered leaf blower ban will end for the season on October 31. Gas-powered leaf blowers will be permitted between November 1 and April 30. As a reminder, the use of landscaping and tree trimming equipment, including but not limited to lawnmowers, tractors, leaf blowers, trimmers, chippers and chainsaws, shall be permitted only between the hours of 7:00 a.m. and 7:00 p.m. weekdays, and Saturdays between the hours of 8:00 a.m. and 5:00 p.m. The use of landscaping equipment by homeowners, including lawnmowers, leaf blowers and trimmers, shall be permitted between the hours of 8:00 a.m. and 5:00 p.m. on Sundays. Commercial use of landscaping or tree trimming equipment, as described above, by contractors shall be prohibited on Sundays and state and federal holidays.
- The Suffolk County General Election will take place on Tuesday, November 7. The polling place for registered voters will be North Haven Village Hall, 335 Ferry Road. - In December, 2022, the North Haven Board of Trustees passed a new lighting code that gave North Haven residents 12 months to implement. The date for compliance is coming up soon - no later than December, 2023. If you have not yet reviewed the code and made any necessary changes to the lighting on your property, please review the summary HERE or the full code HERE.
