

PLANNING BOARD PRELIMINARY SITE PLAN APPLICATION FORM

NOTE: With this application, your project will receive review at ONE 45-minute Planning Board Work Session. You may submit additional Preliminary Site Plan applications if desired.

The purpose of Preliminary Site Plan review is to enable the applicant together with the Planning Board to examine a forthcoming Site Plan submission prior to the applicant committing substantial effort and/or expense toward the plans and details necessary for a formal Site Plan application. During the Planning Board Work Session, the Board will review the preliminary plan and offer the applicant feedback with respect to layout and use. The applicant should be prepared to discuss the project, how the site will function, and possible alternatives.

Sometimes, however, the Planning Board will be unable to give direction to the applicant regarding Preliminary Site Plan without the details required by a full Site Plan.

The Preliminary Site Plan application must be fully completed and submitted to the Planning Board with the following items:

- 1. Review Fee \$400.00 in the form of cash or check made payable to the Village of North Haven
- 2. Nine (9) copies (original plus eight copies) of the completed application form
- 3. Nine (9) copies of plans (i.e. survey/site plan/drawings) confirming to the requirements of Section 163 of the Village Code.

*All paper copies of documents, plans, maps & photos submitted to the file must also be submitted in digital form. This may be in the form of (1) a flash drive or (2) an email with pdfs.
