Discuss: Water Quality Initiatives.

Trustee Diat stated, as the Board knows, North Haven was awarded a grant for an I/A System at Village Hall and agreed to submit an application in 2024 if they were successful. She proposed continuing work with Vin of The Raynor Group to submit another application to the CPF in 2024. Eight locations were identified for infra-structure improvements that could benefit, including a culvert under Route 114, across the street from Ryders Pond and areas around Polls Creek and Great Salt Pond, and Coves End Lane. Trustee Diat requested funds for The Raynor Group to provide pre-engineering services needed to submit an application to the CPF and will obtain an estimate for his services at the January meeting.

Discuss: Tick Drag Results.

Deputy Mayor Abraham provided the Board of Trustees with an update on a meeting he attended with a Suffolk County Advisory Committee regarding ticks and deer. He was asked to make a presentation at their next meeting regarding what North Haven does, where we were in 2019 and where we are now. Chris Miller performs a tick drag in pre-defined areas twice a year, in the summer and fall conducts 30 drags at six different sites. Intention not necessarily to show overall development of our tick numbers but how drag sites work in proximity to 4-Posters. Presentation made indicated a clear uptick in 2019 when the program was abandoned and when it was relaunched in 2022, there was a clear decline. Discussed the Suffolk Share Program to secure favorable pricing on corn for next year which concluded with Mayor Fiore stating that there was a substantial return on the \$180,000 budgeted for this year.
