MOORING PERMIT APPLICATION SPRING 2024

Dear Applicant:

Welcome to the Village of North Haven Waterways. If you wish to submit an application for the upcoming season, please fill out the attached form with the details of your vessel. The completed application is to be sent to or dropped off at the village office along with your payment. Please note that mooring fees are non-refundable, and a surcharge will apply to vessels left in the mooring field beyond October 31st. The season begins May 1st.

Moorings are issued on a first come basis. Residents have first priority.

January 2nd – end of February: Residents only can submit applications.

March 1st – April 30th: Window opens up for non-residents to submit applications but residents can still submit.

FEES: Residents: \$350.00
Non-Residents: \$1200.00

Moorings are non-transferable.

- The Village will also require, as part of your application, proof of mooring inspection including the last date of inspection of all ground tackle by your private contractor.**
- Please include a copy of a valid registration or other current documentation.**
- Also include a copy of your current Insurance Policy.**

***Incomplete applications without all of the above documents cannot be accepted.**

PLEASE NOTE THE FOLLOWING INFORMATION:

These Waterways are a **STATE REGULATED NO DISCHARGE HARBOR ZONE**. A pump out service is provided by the Town of Southampton and can be reached on VHF 73. All vessels are subject to compliance inspections by the Harbormaster, state and local law enforcement officers. All vessels are to be secured in a seamanlike fashion with the appropriate lines and chafing gear. Owners assume all responsibility for the safe keeping of their vessel and are responsible for any damage caused by said vessel.
