Letter from Mayor Chris Fiore

Good day North Haven residents --

Paramount on my mind this week is the untimely passing of our Village Clerk, Eileen Tuohy. She was one of a kind. A person who cared deeply about this village we inhabit, its surroundings, its residents, its natural beauty. I have heard from so many of you in response to the email this week. You commented on how she never shirked her responsibility, was consistently pleasant and cheerful -- always followed up on your guestions and requests.....she will be sorely missed.

Visiting hours are this Sunday the 20th at Yardley Pino, 5-8pm. Funeral services are set for Monday morning, 11am at Queen of the Rosary R.C. church in Bridgehampton. There will be a reception at our Village Hall following her burial at Oakland.

Our Hall will be closed Monday until 1:00 pm.

Councilman Schiavoni and representatives from the CPF held a meeting last evening at Town Hall in S'hampton. It was the first of two Open Hearings, intended to glean thoughts and comments on a plan devised by the 2 park committees for the 10 acres of the Lovelady property and the field behind. Only a few residents appeared, either on Zoom or in person, and I would hope we will hear from many more of you when we meet again at our Village Hall this coming Thursday, August 24. It has always been the intention of former Mayor Jeff Sander, myself and the Board of Trustees, along with Councilman Schiavoni, to create a greenspace that is accessible to NH residents, while keeping the fragile ecology of the area top of mind. We have almost 300 acres of open space in our Village; we hope you agree the field containing Cilli/Sebastian pond, can be made available to us for safe and reasonable public access. The plan is available on our website **northhavenny.us** (gov't, parks tab) and we have also posted boards in the conference room at VHall for you to see. Please give us your time this next Thursday at 6 for a review of the Park committee's plans and the opportunity for you to weigh in your thoughts. PS: our Board of Trustees meeting is scheduled for Wednesday, the 23rd, at 5pm.
