**A LOCAL LAW AMENDING VILLAGE CODE CHAPTER 151 – ARTICLE II SENIOR CITIZEN
TAX EXEMPTION SECTION §151-20 INCOME LIMITS AND EXEMPTION
PERCENTANGAGES**

**BE IT ENACTED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF NORTH HAVEN AS
FOLLOWS:**

SECTION 1: THE AMENDMENT OF VILLAGE CODE CHAPTER 151 ARTILCE II - §151-20

Article II

Senior Citizens Tax Exemption

§ 151-20 Income limits and exemption percentages.

Persons 65 years of age or over owning qualifying real property in the Village of North Haven shall be eligible for a tax exemption in the following percentages, provided that said persons meet the following maximum annual income eligibility requirements:

Annual Income	Percentage of Assessed Valuation Exemption from Taxation
Up to \$29,000 \$50,000	50%
\$29,001 up to \$30,000 \$50,001 up to \$51,000	45%
\$30,001 up to \$31,000 \$51,001 up to \$52,000	40%
\$31,001 up to \$32,000 \$52,001 up to \$53,000	35%
\$32,001 up to \$32,900 \$53,001 up to \$53,900	30%
\$32,901 up to \$33,800 \$53,901 up to \$54,800	25%
\$33,801 up to \$34,700 \$54,801 up to \$55,700	20%
\$34,701 up to \$35,600 \$55,701 up to \$56,600	15%
\$35,601 up to \$36,500 \$56,601 up to \$57,500	10%
\$36,501 up to \$37,400 \$57,501 up to \$58,400	5%
