


200 Year Aggregated Nitrogen Load Components - Existing Conditions






I/A OWTS with General Use Approval



WHAT I/A OWTS HOMEOWNERS SHOULD KNOW

- The average cost for installation of a nitrogen-removing I/A and leaching system and removal of existing system is approximately \$26,000.00. The cost of engineering/design services and site restoration is separate. Costs will vary on a case-by-case basis based on site conditions (soil type, access, depth to groundwater, etc.)
- Covers to Grade
- Control Panels
- Annual Operation & Maintenance
- Electrical Costs
- Repair and Replacement Costs
- Pumping Costs

SUFFOLK COUNTY SIP & NY STATE GRANTS

- Suffolk County Septic Improvement Program (SIP)
 - \$10,000 base grant
 - Add'l \$5,000 for pressurized shallow drainfield leaching system
 - Add'l \$5,000 for installation for LMI eligible applicants
- > NY State Septic System Replacement Program (SSRP)
 - Up to \$10,000 grant
- Town CPF Funds
 - Southampton, East Hampton & Shelter Island
 - Southampton: \$20,000 base rebate with \$5,000 additional for LMI
- Low Interest Loan Program with CDCLI
 - Up to \$10,000 loan
- Grant funding enables Suffolk County to implement upgrades in accordance with the timeline in the Subwatersheds Wastewater Plan, prior to the establishment of a Countywide Wastewater Management District and Countywide Water Quality Protection Fund.

SUFFOLK COUNTY SIP & NY STATE GRANTS

- Apply online at <u>reclaimourwater.info</u>
- County SIP and NYS SSRP administered by SCDHS
- County SIP is not designed as a reimbursement program. Applicants must apply for and receive a grant <u>prior to installation</u> of the I/A OWTS.
- Required documents include: CO, tax bill, homeowner's insurance policy, proof of system failure and, if applying for LMI, recent tax return.
- If property is owned by Trust, LLC, or Corporation, additional documentation is required.
- Grant Awardees must select a Vendor on the County's Approved List, established through a SOQ Process.
- Applicants assign their grant payment directly to the Vendor. Payments are then made by the County to the Vendor.
- Where an applicant <u>is only applying for a State SSRP</u> <u>grant</u>, State SSRP grants may be processed as a reimbursement, and Vendor is not required to be on County List.

1. Prioritize Grant Issuance for Public Health and Safety Concerns

- ✓ Modify Grant Application Scoring
- \checkmark Add Definitions for Catastrophic and Non-Catastrophic Failure
- 2. Upgrade Priority Areas Maps using SWP Mapping
 - ✓ Add-in Drinking Water Protection

***Revised Rules and Regulations are intended to expedite grant issuance for homeowners with failed sanitary systems and to establish priority areas for the protection of drinking water. These revisions are in effect and the website is presently under revision.


NEW SIP GRANT APPLICATION SCORING

- 100 Catastrophic Failures, regardless of the property location
- 90 Non-Catastrophic Failures, regardless of the property location
- 80 Non-Failures, Priority Area 1
- 70 Non-Failures, Priority Area 2
- 60 Non-Failures, Non-Priority Area




UPDATED PRIORITY AREA MAP


UPDATED PRIORITY AREA MAP



- Check property eligibility: <u>https://gis.southamptontownny.gov/parcelsearch/</u>
- Complete and submit Septic Rebate Application and W-9 Form to the CPF office via mail or email (<u>SepticRebate@southamptontownny.gov</u>)
- Submit invoice certification form, invoices, proof of payment, certificate of electrical compliance and certificate of wetlands compliance, if applicable, and inspector certification letter, retrofit letter, or final green stamped plans from the County.
- Rebates must be processed within 1 year of final green stamped plans.

What does the Rebate Cover?

The rebate covers any costs associated with the upgrade of your system such as:

- removal of old system
- Design/engineering
- labor and materials for new system
- 3-year maintenance contract
- property restoration


