- 4. THE VILLAGE WILL POST A NOTICE OF YOUR APPEAL IN THE OFFICIAL NEWSPAPER OF THE VILLAGE, HOWEVER IT IS THE APPLICANTS RESPONSIBILITY TO NOTIFY THE NEIGHBORS WITHIN A RADIUS OF 200 FEET OF THE SUBJECT PREMISES BY CERTIFIED MAIL. PLEASE SUBMIT ALL COPIES OF THE CERTIFIED RECEIPTS AND AN AFFIDAVIT OF MAILING AT LEAST 5 DAYS BEFORE THE SCHEDULED HEARING. IT IS NOT NECESSARY TO POST THE PROPERTY.
- 5. THE APPLICANT, HIS/HER AGENT/ATTORNEY, WILL BE NOTIFIED BY THE VILLAGE, OF THE DATE, TIME AND PLACE OF THE HEARING.
- 6. APPLICATIONS BEFORE THE VILLAGE OF NORTH HAVEN ARE REVIEWED UNDER THE CRITERIA SET FORTH IN NYS VILLAGE LAW SECTION 7-712-b. THE APPLICANT/AGENT/ATTORNEY MUST ADDRESS THE AFOREMENTIONED CRITERIA IN BOTH THE WRITTEN AND PUBLIC HEARING PORTION OF THE APPLICATION.
